# C. FITI BOARD MEETING

Mr. Michaud attended the FiTI Board meeting which was held in Germany early December 2018. The meeting focused on:

- The different policies which will be in place under FiTI initiative and
- the date by which the transfer of the International FiTI Board will be finalised.
- Mr. Fonseka wanted to know how FiTI would help the Seychelles Trade?

## AOB/Way forward

- 1. Mr. Michaud informed members that the Sustainable Blue Economy Conference took place in November 2018 in Kenya and that President Faure spoke of FiTI in most of his speeches. One of the bilateral meetings with Norway was qualified as fruitful as the latter expressed interest in financing FiTI.
- 2. In October 2018, Seychelles also made a commitment at the Ocean Conference held in Bali. Vice-President Meriton participated as a Panelist in a forum where he spoke of Transparency.
- 3. There's a great possibility that the World Bank might create a new fund called PRO BLUE which will be funded by International donors
- 4. Members proposed that SFA's participation/involvement in FiTI will be vital, especially with regards to the Secretariat.
- 5. The next meeting is planned for Monday 28<sup>th</sup> January 2019 at 11am.
