	<p><u>Welcoming of members.</u></p> <p>Mr. Philippe Michaud - FiTI National Lead chaired the meeting, which started at 10am.</p> <p>He welcomed all members and commented on how, he as the FiTI National Lead, was glad to see an increase in the participation of members compared to previous meetings. He expressed his wish that this high level of attendance continues for other FiTI-NMSG meetings.</p>	All members
1.0	<p><u>Confirmation of Minutes of Seventh Meeting.</u></p>	
1.1	All members present endorsed unanimously the Minutes of the 07 th NMSG-FiTI meeting.	National FiTI Coordinator
1.2	Mr. Jude Talma pointed out that he was representing the Department of Fisheries and not the government as a whole. Therefore, the minutes of meeting should clearly show who is responsible for what in the action column.	
2.0	<p><u>Presentation by Mr. Sven Biermann.</u></p>	
2.1	<p>With the permission of the NMSG members, Mr. Philippe Michaud invited Mr. Sven Biermann, the Director of the FiTI International Secretariat to do his presentation FiTI.</p> <p>Before beginning his presentation, Mr. Biermann thanked the NMSG members and commented on the very important role they played for the Seychelles in achieving its candidature status. He also explained that the most important and exciting part of the work will now start; that is to make Seychelles FiTI compliant and the input of all NMSG members is vital at this point.</p>	
2.2	Mr. Sven Biermann then made a presentation on the Fisheries Transparency Initiative. He explained to the NMSG members about the different steps involved in the upcoming FiTI reporting -process as well the 12 FiTI transparency requirements. The presentation also emphasized on the importance and purpose of the FiTI report. The presentation is

2.3	Mr. Talma expressed that care should be taken on the amount of information that should be made available while satisfying the FiTI requirements.	National Coordinator
2.4	On the same line, Mr. Sebastian Pillay commented on the fact that Seychelles' fishery is already heavily subsidized and that the transparency initiatives of the FiTI will mean that all information, about Seychelles' fishery will be available for prospectors in the industry (especially foreign companies) who may use this information to the disadvantage of Seychelles. Mr. Pillay gave the example of the European Union fishing vessels that were already overfishing tuna species in our EEZ and who could use the information provided by the FiTI to gain more advantage when exploiting our own resources. Mr. Sebastian Pillay underlined that his concern is all about the use of information, that may be made available and which can be used against our own fisheries industry. He also stated that we should be careful of the audience that the report will be targeting.	FiTI
2.5	Mr. Beatty Hoareau stated that at times very little is known on what is being discussed as regards to subsidies in fisheries at the international level. He expressed the need for Seychelles to have a clear 'Blueprint' for investors, especially international companies, coming in the fisheries industry in Seychelles. He also outlined that in general, information on the fisheries sector is often perceived as being "all over the place" and the FiTI is a welcomed initiative to consolidate the access to information.	
2.6	Mr. Talma commented on the fact that Seychelles can defend itself through its Fisheries Management Plan which will guide how investment in the Fisheries Industry should be done and this same document can be shared to all the potential investors.	Dept. of Fisheries.
2.7	On this matter, Mr. Chrytold Chetty pointed out that subsidies are not the issue in all of this. He explained that the government and all local stakeholders in the fisheries industry should decide what is exactly better for the country and look at	Transparency Initiatives Seychelles.

2.8	<p>the situation and try to see the bigger picture.</p> <p>Mr. David Bentley suggested on the fact that such reports does not necessarily need to show how wide our resource base is in the fisheries sector. He recommended that a balance should be s struck in what should be totally transparent and available to everyone and what should not.</p>	National Coordinator FiTI
2.9	<p>Mr. Biermann responded to these concerns by pointing out that there is a lot of evidence that shows that transparency is a key aspect in managing the sector in a sustainable way. He emphasized that the FiTI does not directly tell countries how fisheries can be improved nor does it set out to highlight mistakes or weaknesses in decision making, or bad fishing practices. Instead, by making fisheries management more transparent and inclusive, the FiTI promotes informed public debates on fisheries policies and supports the long- term contribution of the sector to national economies, as wellas the well-being of citizens and businesses that depend on the marine environment. In order to contribute to this, Mr. Biermann informed the NMSG that the International Secretariat is offering to conduct two workshops to promote the Seychelles' first FiTI report; one preparatory workshop to inform the public about the FiTI report, and a launch workshop to discuss the results and the NMSG recommendations for further improvements. Mr. Biermann outlined that currently, a small committee is being set up to help the secretariat organizing these two events. He requested the participation from 2-3 members of the NMSG.</p> <p>Mr. Michaud outlined that he will provide nominees to the secretariat soon.</p>	Director International Secretariat. FiTI

3.0	<u>Consultancy for the Preparation of the Seychelles National Fisheries Transparency Report.</u>	
3.1	<p>Mr. Philippe Michaud explained to the NMSG members that the Blue Economy Department together with the FiTI International has already published applications for the consultancy for the preparation of the Seychelles National FiTI Report. There are eleven (11) individuals who have applied. Mr. Michaud went on to explain that the NMSG has to elect a member to sit on the panel to evaluate the consultants documents and chose the best candidate for the preparation of the report. He also suggested that Mr. Chrystold Chetty be chosen for this task since he already had a considerable amount of experience in transparency matters in the Seychelles.</p>	National FiTI Coordinator.
